

LIFETIME WARRANTY ON SHUTTER FRAME AND SHUTTER PANEL

Shutter is warranted against such defects in material that might result in blistering, peeling, flaking, corroding and fading of the shutters frame or panel members for a period of TWENTY-FIVE (25) YEARS from the date of installation. This Limited Warranty on the Vinyl frame and Vinyl panel members shall remain in effect only if normal cleaning practices are followed periodically (see section of this Limited Warranty entitled (Maintenance Cleaning).

5 YEAR WARRANTY HARDWARE - SKANDIA warrants that the hardware will remain in good operational condition for a period of FIVE (5) YEARS from the date of installation.

For stubborn stains, a cleaner such as Fantastic or VIM may be used. Caution: Do not use harsh abrasives on vinyl.
